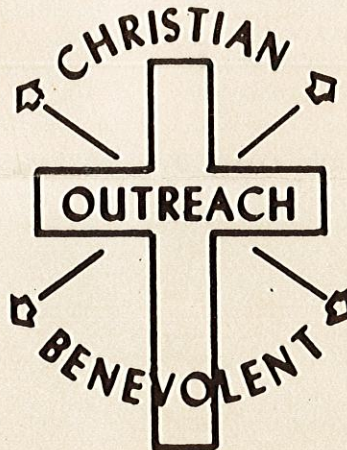
We are mailing this issue as first class mail because we

The program will, of course be non-profit where the best of skilled care will be maintained at all levels at a figure far less than the ordinary retirement, convalescent or nursing facility would cost. The entire project will not only be non-profit but will be operated by Christians in a Christian manner and in a Christian atmosphere.
